Cosplay Contest at FANTASY BASEL – The Swiss Comic Con-Conditions of Participation & Regulations



Conditions of Participation

- The registration period for the Cosplay Contest is open until May 11, 2025 at 23:59.
- All participants must be at least 16 years old at the time of the contest.
- Participants of the Swiss Cosplay Contest must be residents of Switzerland at the time of the contest.
- The Newcomers Cosplay Contest is for cosplay newcomers. Participants of the Newcomers Cosplay
 Contest confirm with their registration that this is their first or second time ever participating in a cosplay
 contest.
- For the Swiss Cosplay Contest and the International Cosplay Contest, the cosplay must be at least 80% self-made.
 For the Newcomers Cosplay Contest, the cosplay has to be at least 70% self-made.
- The costume must have never been awarded a prize at a cosplay contest before.
- Participants must have a festival ticket for the day of the contest.

Registration

- The registration takes place with the submission of the registration form.
- The submission of the registration form does not entitle the participant to take part in the contests.
 A pre-selection will be made and after the registration period, the participation will be confirmed or canceled in writing by the organizer.
- Only one contest per cosplay can be entered. If participants wish to enter more than one contest, they
 must enter a different cosplay in each contest.
- Categories: It is possible to register with several people for the category "group" or as an individual for the category "solo". Group and solo performances will be judged differently. If there are too few group entries, the category "group" will be canceled.
- All required materials must be submitted by the registration deadline:
 - Mandatory: Registration form
 - Mandatory: Reference picture of the character
 - Mandatory: Photo(s) of the cosplay (work in progress also possible)
 - Optional: Music file for the stage performance (correctly cut, good sound quality)
 - Optional: Background image for the stage performance (high resolution)
- The reference picture (character template) must show the character completely and in as much detail
 as possible (different perspectives, close-ups of details). The submission of another picture/collage of
 individual details of the cosplay is possible. The cosplay will be judged based on the submitted character
 template. The character, as well as its clothing, equipment, and weapons, may not be changed in the
 reference picture and should be realized completely and accordingly. For own creations and OCs, a detailed
 sketch must be submitted.



Performance

- The performance time for solo performances is max. 1:00 minute, for groups max. 2:00 minutes.
- Individual music/sound and a still background image during the performance are allowed if the materials have been submitted to the organizer in time (before the registration deadline or individually agreed date).
- Playing a background video during the performance is not possible.
- If no music file or background image has been submitted, the organizer will play neutral music and show a neutral image.
- During the performance, the participant is not allowed to use a live microphone. Sketches must be prerecorded and pre-submitted with the sound file.
- The stage may not be soiled by the performance (e.g. by confetti, liquids, soap bubbles, flour, fire, dry ice, chemical effects, etc.).
- Smoke effects must be announced in advance and approved by the organizer.
- No objects may be thrown into the audience or the jury.
- Indecent or disturbing behavior on stage and during the prejudging is not permitted.
- Depictions of extreme violence, pornography, etc. are not permitted. Note: In case of uncertainty, it is recommended to clarify those with the organizer in advance.
- Indecent behavior during the entire event will result in immediate disqualification.
- No live animals may be used for the performance.
- The costume must be worn on the body by the participant (e.g. no puppets).
- Props are permitted but must be announced in advance and approved by the organizer. The organizer may
 prohibit the use of individual weapons, costumes, or props.
- The cosplay and weapons regulations as well as the Swiss Weapons Act must be observed by all
 participants.
- The cosplay contest team on site handles the placement of props on stage.
- Weapons, props, and costumes must not be made of easily flammable material.

Judging

- The contest is run by the contest lead and judged by a panel of judges.
- The jury consists of the cosplay guests of the event.
- The decision of the jury and the instructions of the contest lead are final.
- Any attempt to influence the jury and/or the contest lead will result in disqualification.
- The costume worn at the judging must be worn in the same manner at the performance. Small deviations, such as more secure but visually similar shoes, may be permitted by the contest management.
- The judging will be based on the costume (50%) and the presentation/performance (50%).
- The costumes are judged by the following criteria: Accuracy and precision, workmanship, complexity and technique, material, and overall impression.
- The performances are judged by the following criteria: staging, quality and use of media, accessories and props, creativity and entertainment, coherence and comprehensibility as well as the overall impression.
- The costume judging by the jury takes place in the judging room without spectators.
- The performance judging by the jury takes place on the Main Stage with spectators.
- The awards are presented after the contest and the performances on the Main Stage.
- The jury can only award one prize per cosplay. Exceptions must be approved by the contest lead.



Procedure

- On the day of the contest, there is a staging in the morning, where participants can briefly get to know the stage.
- Afterward, the pre-judging takes place in a separate judging room, where the jury evaluates the cosplay from up close.
- In the afternoon, the performances take place on the Main Stage, followed directly by the awards ceremony.

Other

- During FANTASY BASEL The Swiss Comic Con, photos, audio, and video recordings are made of the participants. By taking part, participants agree that any material may be used and passed on by FantasyCon AG (organizer of FANTASY BASEL – The Swiss Comic Con) and its partners without restriction and remuneration.
- The contest rules are subject to change at any time.
- Non-cash prizes cannot be paid out.
- Cash prizes are transferred by bank transfer after the event.
- Violation of the rules results in disqualification from the contest.
- The general terms and conditions as well as the weapons and cosplay rules of FantasyCon AG apply.
- · Changes to the prizes can be made at any time.
